**PROGRAM RATES & DATES**

**DEPOSITS:** Summer Day Camp and Meta Meets Camp registration requires a \$25 deposit per week per camper. Deposits are non-refundable and non-transferable. This deposit is due immediately upon registration to hold a camper's spot. Deposit payments apply towards camp fees. If you are applying for financial assistance, your camp registration requires a \$12.50 deposit per week, per camper. If you are approved for the Child Care Assistance Program (CCAP) or DCFS assistance, your camp registration requires a \$5 deposit per week, per child.

**WAITLISTS.** Waitlists are started when a camp session is filled. There is no fee for a wait list registration. If your child is offered a spot in camp from the waitlist, your registration deposit will be due immediately and/or full payment will be assigned if the due date has passed.

**PAYMENTS & FEES:** Full payment for each camp week must be received by the due date listed in the chart below. Registration is by the week; the weekly rate will not be prorated. If registering for a camp week after the due date, full payment is due immediately. If registering for a camp after May 17, a late registration fee of an additional \$25 per week will be charged. **Camper's will not be allowed to attend camp with a balance due.**

**MULTI-CHILD DISCOUNT:** Families with more than one child concurrently enrolled in Day Camp or any full-day programs at the McGaw Y Children's Center will receive a \$25 discount for each week. The discount applies to the lowest fee/tuition rate.

**I am applying for Financial Assistance.** Financial assistance is available for families with documented financial need. To apply, submit a McGaw Y Children's Center Financial Assistance application along with a copy of your most recent federal 1040 tax form, a printed camp registration form, and \$12.50 deposit per week, per camper. PDF versions of these forms can be found on the website. Paper copies are available at the Children's Center front desk. Your child must be a McGaw Y member to be eligible for YMCA financial assistance. This membership requirement is not applicable to CCAP or DCFS assistance. The financial assistance application is processed at the same time as registration. If we do not receive a copy of your 1040 form at the time of registration, any awarded financial assistance will only be applied to future payments starting from the date you submit the 1040 form. You will receive notification by mail about the status of your financial assistance award within two (2) weeks of submitting the application. Returning campers must fill out a new McGaw YMCA Financial Assistance Application each year and provide a copy of their most recent 1040 form or proof of income. If the awarded assistance is not sufficient to enable your camper to attend, we will refund your deposit. You must notify us by the due dates specified in your financial assistance letter to be eligible for a deposit refund.

**I am approved for the Child Care Assistance Program or DCFS Assistance.** Please include your approval letter with this form to pay the reduced \$5 deposit per week, per camper.

Required Paperwork. A completed and signed Summer Day Camp Enrollment packet is required for each camper. The enrollment packet will be emailed to the registering parent/guardian and must be turned in to our Registration Team by April 30 in order for your child(ren) to attend camp.

Billing. Families who are not signed up for automatic draft will be sent an invoice two weeks prior to each full payment due date. All invoices will be emailed to the Registering Parent/Guardian's address provided at the time of registration.

Campers with Disabilities. The McGaw YMCA is fully committed to the participation of all individuals in our programs. We will make every effort to accommodate your child's needs within our available resources.

Camp Cell Phone. I acknowledge that the Registering Parent/Guardian will be provided with the camp cell phone number for direct communication with camp staff. I understand that staff will be available to answer calls or texts to the camp cell phone Monday through Friday between 8:00am and 9:00am and between 4:30pm and 5:30pm.

Pick-up/Drop-Off. I acknowledge that my camper is required to be signed in between 8:00am and 9:00am and signed out between 4:30pm and 5:30pm each day, unless prior notice is given. I understand that an authorized adult (18 and older) listed on the Authorized Pick-Up list must physically sign in and out my child(ren).

Additional acknowledgements:

- I understand that if there is more than one parent/guardian listed on this form, the parent/guardian signing below will be designated as the "Registering Parent/Guardian" responsible for managing the camper's enrollment information and submitting all payments.
I understand that I am responsible for following the policies and procedures outlined in the specific program guidelines including the Parent/Guardian handbook.
I understand YMCA staff are mandated by state law to report any suspected cases of child abuse or neglect to the appropriate authorities for investigation.
