PROGRAM RATES & DATES

DEPOSITS: Summer Day Camp registration requires a \$25 deposit per week per camper. Deposits are non-refundable and nontransferrable. This deposit is due immediately upon registration to hold a camper's spot. Deposit payments apply towards camp fees. If you are applying for financial assistance, your camp registration requires a \$12.50 deposit per week, per camper. If you are approved for the Child Care Assistance Program (CCAP) or DCFS assistance, your camp registration requires a \$5 deposit per week, per child.

WAITLISTS. Waitlists are started when a camp session is filled. There is no fee for a wait list registration. If your child is offered a spot in camp from the waitlist, your registration deposit will be due immediately and/or full payment will be assigned if the due date has passed.

PAYMENTS & FEES: Full payment for each camp week must be received by the due date listed in the chart below. Registration is by the week; the weekly rate will not be prorated. If registering for a camp week after the due date, full payment is due immediately. If registering for a camp after May 16, a late registration fee of an additional \$25 per week will be charged. Campers will not be allowed to attend camp with a balance due.

To apply, submit a McGaw Y Children's Center Financial Assistance application along with a copy of your most recent federal 1040 tax form, a printed camp registration form, and \$12.50 deposit per week, per camper. PDF versions of these forms can be found on the website. Paper copies are available at the Children's Center front desk. Your child must be a McGaw Y member to be eligible for YMCA financial assistance. This membership requirement is not applicable to CCAP or DCFS assistance. The financial assistance application is processed at the same time as registration. If we do not receive a copy of your 1040 form at the time of registration, any awarded financial assistance will only be applied to future payments starting from the date you submit the 1040 form. You will receive notification by mail about the status of your financial assistance award within two (2) weeks of submitting the application. Returning campers must fill out a new McGaw YMCA Financial Assistance Application each year and provide a copy of their most recent 1040 form or proof of income. If the awarded assistance is not sufficient to enable your camper to attend, we will refund your deposit. You must notify us by the due dates specified in your financial assistance letter to be eligible for a deposit refund.

Required Paperwork. A completed and signed Summer Day Camp Enrollment packet is required for each camper. The enrollment packet will be emailed to the registering parent/guardian and <u>must be turned in to our Registration Team by April 30 in order for your child(ren) to attend camp</u> . The enrollment packet includes required state licensing forms as well as information about camp (what to bring, camp expectations, etc.).
□ Billing. Families who are not signed up for automatic draft will be sent a payment reminder five (5) days prior to each full payment due date. All reminders will be emailed to the Registering Parent/Guardian's email address provided at the time of registration. We are unable to send invoices to multiple email addresses. I understand that if I register <i>after</i> May 16, a late registration fee applies and is due with registration payment.
□ Campers with Disabilities. The McGaw YMCA is fully committed to the participation of all individuals in our programs. We will make every effort to accommodate your child's needs within our available resources. I acknowledge that I have reached out to Andrea Hillsamer at 847-475-8580 ext. 313 <i>prior to submitting this registration application</i> to discuss potential options. If my child has a current 504/Individualized Education Plan (IEP), I will include it with my camp enrollment packet or submit it directly to Alex Richardson at alexandrar@mcgawymca.org .
☐ Communication. I understand that the Registering Parent/Guardian can contact day camp staff by calling the McGaw YMCA Children's Center at 847-475-8580 (your call will be forwarded to the on-site manager). Staff are available to answer calls or texts Monday through Friday from 8:00am to 9:00am and 4:30pm to 5:30pm. Outside of these hours, I can leave a voicemail or email daycamp@mcgawymca.org, and staff will respond as soon as possible. For urgent matters or emergencies, please call the McGaw YMCA Children's Center at 847-475-8580.
Pick-up/Drop-Off. I acknowledge that my camper is required to be signed in between 8:00am and 9:00am and signed out between 4:30pm and 5:30pm each day, unless prior notice is given. I understand that an authorized adult (18 and older) listed on the Authorized Pick-Up list must physically sign in and out my child(ren). It is clear to me that my child(ren) may not be left at the program site unless they have been properly signed in with YMCA staff. Outside of the designated sign- in/out times, I understand the building entrances will be closed and locked from the outside. The presence of staff at the door cannot be guaranteed. If I arrive outside the specified sign-in/out times without prior notice, entry can be arranged by contacting the camp cell phone. I should be prepared to wait, as staff may be engaged in activities away from the building. Additional Acknowledgements:
• I understand that if there is more than one parent/guardian listed on this form, the parent/guardian signing below will be designated as the "Registering Parent/Guardian" responsible for managing the camper's enrollment information and

- submitting all payments.
- I understand that I am responsible for following the policies and procedures outlined in the specific program guidelines including the Parent/Guardian handbook. If I fail to meet my obligation to the program policies, the McGaw YMCA reserves the right to suspend my child(ren)'s participation in the program.
- I understand YMCA staff are mandated by state law to report any suspected cases of child abuse or neglect to the appropriate authorities for investigation.
- I understand that deposits and program fees are non-refundable and non-transferable. I understand that program fees will not be prorated for days missed due to weather, holidays, disruptive behavior, etc. and may not be made up, credited, or refunded.
- I understand that failure to pay all camp fees, including late fees, may result in termination of services.
- I understand the YMCA is not responsible for lost, damaged, or stolen articles.
- I give permission to photocopy all forms.
